## **Oral Health Education-Certification and Monitoring Legislation A Process of Due Diligence**

*National Governors Association conducts a case study highlighting how the law was passed in 2012.*

**Baltimore, Maryland** (March 29, 2013). The outcome of Maryland's sound collaborative efforts achieved the 2012 *Oral Health Education-Certification and Monitoring* legislation. This due diligence by Maryland legislators, policy makers, oral health professionals, school educators, parents and other stakeholders offers a process others may be able to replicate. The pathway taken by organized dentistry shows promise and could help to influence the measures being contemplated by other states to have oral health incorporated into their public school curriculum.

The National Governors Association has conducted a case study highlighting how the law was passed in 2012.
